- Discussion took place concerning current GOAL scholarship guidelines: the amount of tuition assistance that a student is eligible to receive is generally 20% 50% of tuition.
- **RECOMMENDATION** from the Finance Committee that in instances of unexpected hardships beyond a family's control (illness, loss of job, etc.), a family may apply and be awarded an additional scholarship amount. Second made by Steve Collins. Motion passed.
- PLEASE BE ADVISED: As an elected official, Heather Lanier, Superior Court Judge of the South Georgia Judicial Circuit: "under the Georgia Code of Judicial Conduct, which governs activities and actions of judges, Rule 3.7(B)(1) states, "[j]udges may serve as officers, directors, trustees, or non-legal advisors of educational, religious, charitable, fraternal, or civic organizations not conducted for the economic or political advantage of their members, subject to . . . limitations. . . . " I cannot give investment advice to any organization, but I can serve on the board and participate in its management, even if that tangentially involves responsibility

for approving investment related decisions. However, Rule 3.7(B)(2) states, "[j]udges shall not personally solicit funds for any educational, religious, charitable, fraternal, or civic organizations, or use or permit the use of the prestige of their office for the purpose, but they may be listed as officers, directors, or trustees of such organizations." So, I can participate on the board, but I just cannot personally, directly advertise or solicit funds for the school, whether as a board member or not. If there are any questions or concerns, please let me know. Thank you. Heather Lanier". Relevant pages of the current Georgia Code of Judicial Conduct will be attached to the official meeting record.
